





Responding to any CHNA is not simply the responsibility of the health network and providers. Rather, an examination of efforts across multiple community sectors and agencies and subsequent collaborative actions are most likely to have a sustained impact on the community's health. When community leaders come together to prioritize needs, determine next steps, and to work toward health improvements in collaboration with each other, success is more likely. This is a collective impact approach and Wayne Memorial is committed to working with community partners in an effort to systematically improve the region's health.

1. Significant Health Need: Access to Care and Transportation- As a rural community, the Wayne Memorial service area has limited public transportation, limited ambulance service, and encompasses a wide geographic area. In addition, Wayne and Pike counties has healthcare provider shortages which pose challenges to access and quality of care. Together, these can hinder access to available care for community members, particularly for those households with limited vehicle access and those located further from population centers.

Unmet Need Indicators:

- Transportation remains a barrier to healthcare access in the Wayne Memorial (WM) service area, particularly for seniors, individuals with disabilities, low-income families, and those living in the further reaches of the service area.
- High appointment cancellation rates stemming from no transportation causes strain for the healthcare system.
- Long wait times for shared rides, resulting in full-day commitments for medical appointments cause strain for patients.
- Emergency Medical Services (EMS) in the Wayne Memorial service area, and across rural Pennsylvania, continue to struggle with long response times, staffing shortages, and financial constraints.
- There are far fewer primary care physicians, mental health providers, dentists and specialty services including orthopedics, neurology and dermatology, for the WM service area.

- Pike County allocated \$4.4 million to fund 24/7 EMS services, reducing response time.
- WMH is supporting EMS training courses and offering clinical rotations in the emergency department and other hospital departments to help increase the number of qualified responders within the service area.
- Wayne County Transportation Task Force under Wayne Tomorrow! is working to increase availability of accessible and affordable public transportation; additional share ride programs and shuttle service in frequent high travel roadways.
- Continue to work with county government and agencies to help increase efforts to improve issues with transportation.
- WMH, partnered with educational institutions, is a clinical training site for fellows, residents and medical students, providing supervised rotations in their areas of interest.
- WMH has open recruitment for orthopedic and neurology services.
- WMCHC has implemented a Family Medicine Residency Program, providing doctors who have completed medical school and are currently in their threeyear training program, rotations through various clinical settings.

2. Significant Health Need: Mental Health Services - Despite recent progress in expanding local services, the demand for care far exceeds current capacity. Our local counties have fewer mental healthcare providers per population size than does the state, on average. 880:1 population-to-provider ratio in Wayne County; 1080:1 in Pike County VS 350:1 population-to-provider ratio across Pennsylvania.

Unmet Need Indicators:

• There continues to be a shortage of mental health providers which places additional strain on providers who are trying to meet the needs of residents in our communities.

- Barriers continue to exist including limited transportation, childcare challenges, long wait time, and ongoing stigma around mental health conditions which prevent individuals from seeking or receiving care when they need it.
- Individuals experiencing a mental health crisis often turn to hospital emergency departments for help, placing additional strain on hospitals already facing limited resources and highlighting the urgent need for more accessible outpatient mental health services.
- There continues to be a growing need for mental health services across all age groups including young children in daycare, school-aged children and their parents, as well as adults along with increased demand for mental health support groups and related services.

3. Significant Health Need: Transitional Senior Housing - Wayne and Pike Counties have two of the four oldest populations in Pennsylvania; 26% of the population is age 65 or older in Wayne County and 25% in Pike County. The average for PA is 20%. Despite having a disproportionately high number of older adults, the region lacks assisted living and transitional senior housing options that allow residents to age safely and comfortably. Many existing homes are older and not designed for accessibility, leaving seniors vulnerable to falls, social isolation, and unsafe living conditions.

Unmet Need Indicators:

- Wayne County has one assisted living, no transitional senior housing communities and three nursing homes.
- Most nursing homes operate below capacity due to staffing shortages and regulatory constraints, and private pay facilities present a significant financial burden for many families.
- Many older adults who would like to downsize or move into transitional housing, do not find it economically viable and options are limited.

4. Significant Health Need: Health Literacy - Health literacy is the degree to which individuals have the ability to find, understand, and use information and services to inform health-related decisions and actions for themselves and others.

Unmet Need Indicators:

- Community members relay challenges and frustrations in using patient portals, especially among older adults.
- Understanding the health system overall is a challenge and there is a disconnect between patient expectations, the standard of care, and the limits of different health services.
- Community members use multiple sources to obtain health-related information including healthcare providers, online sources and family/friends – yet conflicting or inaccurate information remains a concern.

5. Significant Health Need: Vaccine Hesitancy and Mistrust — Decline in vaccination rates, misinformation and mistrust in the healthcare system make it harder for individuals and families to make confident decisions.

Unmet Need Indicators:

- Decline in vaccinations due to COVID 19 vaccination controversies and politicization of vaccines have complicated provision of this preventive healthcare.
- Lower vaccination rates increase risks of outbreaks across communities as seen with the recent measles outbreak.
- Mistrust of the medical community can be a barrier to care for some within the Wayne Memorial service area with 18.2% reported fear or mistrust of doctors as a rationale for not obtaining needed care

- Offering clear and accessible education, and strengthening partnerships between healthcare providers, schools, and community organizations to help rebuild confidence and support informed decision-making.
- Collaborate with local healthcare providers, public health agencies, schools, libraries and senior centers to share consistent health messages.
- School-based health clinics and hospitalschool collaborations to increase local access to basic care, including vaccinations, are effective strategies for increasing vaccination rates.
- WMH provides mandatory flu vaccines to employees with enforced masking requirements for employees who refuse. Employees who are hesitant, receives education along with printed material to help them make informed decisions on the flu vaccine.
- WMH participates in non-mandated documentation of flu vaccine rates and submits this information which is used by the CDC.
